### TO ALL NATIONAL MEMBER-ASSOCIATIONS

Dear Colleagues,

1 - In the name of the International Association of Judges and of the "Amicale Hassania des Magistrats du Marou", I take pleasure in inviting you to name your delegates to the meetings of the Central Council, of the four Study Commissions, as well as of the four Regional Groups of the IAJ to be held in Marrakech (Morocco), from 14<sup>h</sup> to 18<sup>th</sup> of October 2018.

2 - The meetings will take place at the meeting halls of "Palais des Congrès du Ministère de Bab Ighli".

The delegates are invited to book as a priority at MOVENPICK hotel (<u>www.movenpick.com</u>) or, as an alternative, at SAVOY le Grand Hotel (<u>www.savoylegrandhotel.com</u>).
