TO ALL NATIONAL MEMBER-ASSOCIATIONS

Dear Colleagues,

- 1 In the name of the International Association of Judges and of the *Union of Judges of the Republic of Kazakhstan,* I take pleasure in inviting you to name your delegates to the meetings of the Central Council, of the four Study Commissions, as well as of the four Regional Groups of the IAJ to be held in Astana (Kazakhstan) from 15 to 19 of September 2019.
 - 2 The meetings will take place at the meeting halls of "Hilton Astana" Hotel.

Delegates are suggested to reserve the "Hilton Astana" Hotel as a priority, or, alternatively, "Wyndham Garden Astana" Hotel, "Hampton by Hilton" Hotel.

Daily transfer between hotels will be provided by the Kazakhstan Association.

The accommodation expenses must be covered by each national association for its own delegates.

The Kazakh Association will offer at its own expenses the simultaneous translation (English, French, Spanish, Russian), all the meeting rooms, a welcome party (dinner) on Sunday, September 15th as well as Gala dinner on Wednesday, September 18th (farewell party).

3 - The delegates are expected to arrive on Sunday, 15th of September, 2019 (save delegates to the Regional Groups meetings who are expected to arrive on Saturday, September, 14th 2019) and are expected to leave on Friday, September, 20th.

Transportation between airport and hotel will be provided by the Kazakhstan Association.

4 - Please find here enclosed a provisional programme. A special programme will be arranged for travelling companions. An additional fee (which will be communicated soon) will be charged on any accompanying person and on delegates exceeding the number established for the contribution group to which their national association belongs (see par. 7 of this letter).
